## Young Fives Tuition

Half-Year (starting in Jan)	\$425

*Full Year: \$150 due in May, \$675 due in August  
Half Year: \$425 due by January 1  
(same price for 2, 3, 4, or 5 days per week)*

## Kindergarten Tuition Special

*Non-members pay member rate!*

Non-Member Rate	\$1600
Member Rate	\$1600

*\$150 due in May, \$1450 due in August*

## Grades 1-8 Tuition (Non-Member)

<u>Non-Member</u> Grades 1-8	Total Cost	Monthly Cost
Oldest Child	\$3,700	\$355
Second Child	\$3,450	\$330
Additional Children	\$3,200	\$305

*\$150 due in May, the first monthly payment is due by the first Sunday in August. Subsequent payments are to be paid by the first of each month, ending in May. Monthly payments are over 10 months, less the \$150 registration fee.*

## Grades 1-8 Tuition (Member)

<u>Member</u> Grades 1-8	Total Cost
Oldest Child	\$1600
Second Child	\$1500
Additional Children	\$1400

*\$150 due in May, the balance is due in August. Member tuition will be expected to be paid in full by the first Sunday in August, unless a payment plan has been approved by the School Board Treasurer.*

Note: There is not a multiple child discount for Member Kindergarten students. All Kindergarten students, both Member and Non-Member, pay \$1600 for the year.

**Credit Card Payments**

Families using a credit/debit card to make payments will be charged an additional 2.8% fee at the time of the payment, covering the transaction fee that is applied to all credit card usages. This fee will be applied each time a credit card is used.

**End-of-the-Year Policy for All Students**

All payments are to be completed by June 1 of the current school year. Tuition or Registration Fees not paid in full by June 1 will be charged with interest at the rate of 5% per month on the balance due. New registration will not be accepted until payment is made in full. End-of-the-year report cards will be withheld for students who have unpaid balances for tuition, registration, extended care, and/or preschool tuition (for siblings). Records will not be transferred to another district until all payments have been made in full.

**Tuition Payment Conditions**

1. For Non-Members and Members on a tuition payment plan, payments are due the first of each month. A 5% late fee will be charged if not paid by the tenth of each month. If the due date falls during a school break, payments are due on the first day classes resume. Failure to pay promptly may mean the dismissal of the child from the school.
2. Refunds for any reason are decided by the Elementary Education Board.

**Miscellaneous Conditions for Non-Member Enrollment**

1. All non-member parents/guardians and students agree to follow the policies of Divine Grace as described in handbooks, newsletters, etc. No non-member parent/guardian or student has a voice in the decisions made by Divine Grace Lutheran Church and its Committees.
2. The non-member parents/guardians of student(s) in Young Fives, Kindergarten, or Grades 1-8 may enroll in our 12-week Bible Information Class (BIC) with the Pastor of Divine Grace. If they do not enroll in BIC, the parents/guardians of K-8 students must attend our Introduction to Lutheran Christianity presentation. Both options will acquaint each family with the teachings of our church and school which are being taught each child in the classroom. All parents who have not previously completed this requirement need to do so during the school year in which the child is enrolled in our school. Failure to successfully complete the class may result in the non-member child being released from enrollment in our school. Parents need to speak to the Pastor of Divine Grace for the dates and times.\*
3. Each 7<sup>th</sup> and 8<sup>th</sup> grade non-member student needs to attend our Catechism Instruction Class taught by our Pastor. This class is considered part of our school curriculum. Failure to attend the class regularly may result in the non-member child being released from enrollment in our school.

\* Members of churches in fellowship of the WELS who have students enrolled in the school do not need to take the Bible Information Class. Also, catechism instruction for the students may be carried on in the home congregation of those who are in our fellowship after consultation with our Pastor.

*Divine Grace Lutheran Church and School reserves the right to change the tuition, tuition plan, and conditions of non-member enrollment at any time.*
